## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Lake Stevens Sewer District from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utility billing system review
- Accounts payable
- Third party receipting

## INFORMATION ABOUT THE DISTRICT

The Lake Stevens Sewer District was incorporated in 1957. The District provides sewer services to approximately 30,900 customers in the City of Lake Stevens and the surrounding areas in Snohomish County.

An elected, three-member Board of Commissioners governs the District. Commissioners serve staggered, six-year terms. The Board appoints a General Manager to oversee the District's daily operations as well as its 24 employees. For fiscal years 2014 and 2015, the District had operating revenues of \$11,248,502 and \$11,875,340, respectively.
